### 3. RENTAL REQUIREMENTS RULE #3 -Action

### 4. BOARD OF DIRECTOR'S COMMENTS

Garcia-Members are very passionate on both sides of the rule. He feels the rule is about making the association better.

Keith-The rules does not affect any current owners.

Huntingford-Investors do not pay top dollar for homes and that decreases the value of the surrounding properties.

Stanton-The rule went through legal counsel.

Smith-Appraisers set prices based on the sales, investors drive down prices. This is not an immediate cure but a step in the right direction. Landlords that do not live in the area are not as helpful and those that live here. Escrow gives buyers all association does which will include this rule, most investors avoid HOAs.

McCoy-Not a quick fix but a step in the right direction.
