As we continue our negotiations with Club Corp, I wanted to clear a few things up as we continue to move forward. First being that the club is for sale. Our club has been on a disposition list for some time and in fact they have received multiple offers from different groups interested in owning the club. Club Corp has told us on more than one occasion that they want to be a good neighbor and give us the first chance at purchasing; as they agree with our Board that this is in the best interest of SVL. An outside group owning the club could be disastrous for SVL. Another misconception I have read about recently is that the water rights currently owned by Club Corp would not be transferred with the sale. This is simply not the case. The water

rights have been included in our negotiations from day one. We should have our report from Christovich very soon; and we will have a comprehensive evaluation of the club, from deferred maintenance to operational costs. With this report, we will have enough information to determine the feasibility of this acquisition and have a firm grasp on the financial effects to our budget moving forward. We are sharing information as it becomes available on our website.

As we move towards a vote from the members of SVL, the association needs to have updated contact information from our residents. Please, if you have not already, contact the association and give them your updated contact information. This will ensure that all residents can vote on this acquisition when the time comes! And again, we are always looking for volunteers to help with committees.
