Re: Makeup Water Obligations and Assessments for the 2020-21 Water Year

Watermaster records indicate that you incurred a Makeup Water Obligation of 113.62 acre-feet during the 2020-21 Water Year. The cost of Makeup Water if purchased from the Watermaster is \$563.00 per acre-foot for the 2020-21 Water Year. A preliminary copy of Appendix B showing your Makeup Water Assessment was mailed to you on February 24, 2022. A final draft of Appendix B will be presented to the Watermaster on March 23, 2022. Your Makeup Water Assessment, due on July 1, 2022, is \$63,968.06.

In lieu of payment of Makeup Water Assessments to the Watermaster, you may transfer two (2) acre-feet of 2020-21 Unused Free Production Allowance (Carryover) or 2020-21 Free Production Allowance from a Producer in the Centro Subarea for every one (1) acre-foot of Makeup Water Obligation owed, rounded up to the next whole acre-foot. Therefore, you must transfer **228 acre-feet** from a producer in the Centro Subarea to satisfy your Makeup Water Obligation. If you do not satisfy your Makeup Water Obligation with a transfer, you will be billed for \$63,968.06 on June 1, 2022. Please do not pay this amount until you are invoiced by Watermaster.

Enclosed is the transfer form (Exhibit "J") needed to process this type of transfer. Transfer documents must be submitted to the Watermaster no later than April 25, 2022, to allow the Watermaster sufficient time to process the request. Pursuant to Section 12 Paragraph (C) of the Watermaster Rules and Regulations, if all past due assessments, interest and penalties are not paid by both the Transferee and the Transferor, the Watermaster will take no action on the proposed transfer and the Makeup Water Assessment will be billed. Watermaster records indicate that you incurred a Replacement Water Obligation of <u>442 acre-feet</u> in the Alto Subarea during the 2020-21 Water Year. The cost of Replacement Water if purchased from the Watermaster is \$563.00 per acre-foot for the 2020-21 Water Year. A preliminary copy of Appendix B showing your Replacement Water Assessment was mailed to you on February 24, 2022. A final draft of Appendix B will be presented to the Watermaster on March 23, 2022.

In lieu of payment of Replacement Water Assessments to the Watermaster, you may transfer 2020-21 Unused Free Production Allowance (Carryover) from another Producer in the same Subarea. Appendix B shows all Producers that have Unused Free Production Allowance (Carryover) from the 2020-21 Water Year that may be available for transfer. The court imposed differential rampdown for the Alto Subarea requires that transfers from agriculture to municipal and industrial be adjusted. If you choose to transfer water in lieu of payment of your Replacement Water Assessment from an agricultural producer, the transferred amount will be reduced pursuant to the differential rampdown adjustment. The amount of water you need to transfer to satisfy your Replacement Water Obligation is <u>522 acre-feet</u>. Please do not hesitate to contact Watermaster staff if you need help determining how much water you need to transfer.

Enclosed is the transfer form (Exhibit "I") needed to process this type of transfer. Transfer documents must be submitted to the Watermaster no later than <u>April 25, 2022</u>, pursuant to the Watermaster Rules and Regulations. In addition, Section 12 Paragraph C of the Watermaster Rules and Regulations state that if all past due assessments, interest and penalties are not paid by both the Transferee and the Transferor, the Watermaster will take no action on the proposed transfer and the Replacement Water Assessment will be billed as shown on Appendix B.
