Public Safety Director's Monthly Report  
Board of Directors Regular Meeting

April 21, 2014

- In response to an increase of vehicle burglaries within the Spring Valley Lake community the Public Safety Department initiated a special patrol detail starting on 04/10/2014 at 2200 hours that continued to completion on 04/11/2014 at 0630 hours. Eight units were assigned to the detail. During that time the assigned Public Safety personnel directed their primary focus to suspicious vehicles and persons engaging in actions/manners congruent with criminal activity (specifically automobile burglary/theft). Any activities deemed suspicious or questionable in nature were logged with Public Safety Dispatch and patrol personnel gathered pertinent information and descriptions if opportune or safe conditions applied. Officers compiled a list of observed vehicles, times of observations, geographic locations, suspicious activity indicators and outcomes. No criminal acts were observed during the course of the detail. A detailed summary was submitted to San Bernardino County Sheriff personnel for review.
- Continued in-house training. (SVLA Rules and Regulations, BSIS Powers to Arrest, Command Structure, Dispatching and Lake Patrol.)
- Continued extra patrol on the commercial property.
- ID Checks.
- Continue updating SOP's for Zebra / Quagga mussels inspections.
- Routine duties and proactive patrol.
