



Hope you all are enjoying the warmer weather. I wanted to thank all the residents that took the time to fill out the financial survey that was e-mailed to our community members. I received a total of 150 responses. Although I would have loved to receive more participation, I do believe I received a great sample of the opinions of our community. Most residents identified that they are not interested, or they do not set aside time to review our financial reports or the financial health of our community. I hope that I can change the mindset of

our members and promote more interest and a better understanding of this communities financial well-being.

Based on the feedback, my goal is to release a minimum of two videos a month and include a one-page summary of our financial information in our SVLA Breeze. I want you all to know that I read all of your comments and I plan to implement 98% of the suggestions. A majority of the suggestions will be noticeable and implemented within the next 60 days.

Come to us when you have a question or concern...

Most of the time your question or concern can be resolved by staff within 24-48 hours. I want to remind the community that you are always welcome to contact me with any concerns you may have. I've noticed that 99% of residents

that go directly to the Board of Directors, had never contacted me, as the General Manager, first. I ask that you give my leadership staff an opportunity to answer your questions or solve your concerns before contacting the Board.

Our annual inspections are in full swing; this means the Code Enforcement team will be doing an in-depth check of every home in the community. Even if your home does not have violations and looks great, you may have a code enforcement parked in front of your home for a little bit. This article has a general guideline of some of the things we are checking when completing the inspection; so please try to be proactive if you're having a problem with any of the below items. If you are planning

to make any exterior changes to your property, please make an architectural appointment on the svla.com website. I will be happy to go over your plan and point out any additional items the Architectural Committee may want to help ensure it gets approved. If you're new and you have changed something on the exterior of your house, please submit an application with the changes you already made to get approved and avoid the citation we would send during the annual inspection.

We are looking forward to summer coming at us full force. We are thankful to have the lake coving behind us and we are looking forward to our 2 new set of docks being completed. Our vendor ran into a few delays along the way, causing them to be behind schedule, but they are coming together nicely. They are a nice refreshment for our marina. They are projecting to be completed approximately June 27, 2023.

We have been doing our best to continue with the lake clean up weekly. If you notice any areas with excessive trash or debris, it is always helpful to

let us know. Give the office a call or send an email to maintenance@svla.com.

The lake consultant has finished their report of the lake coving erosion issues and the Board is in the process of reviewing the report and the recommendations to correct.

This summer, we have teamed up with Lahontan water Board to perform a series of Harmful Algae Bloom (HAB) samplings to ensure we stay on top of any possible toxic algae blooms in the lake. Additionally, we will continue to do our standard water sampling and lake data throughout the summer as well as the beach treatments.




Please remember that guests must be accompanied by an association member for this event (Rules and Regulations 2.5.1). The Pub-

lic Safety Department will have a large presence of officers to ensure a safe event for all the residents. We have contacted the Sheriff Department, Fire Department, California Highway Patrol and volunteer forces for their assistance during the event. The beach area and lake will open at 6AM; **NO ONE** will be al-

lowed to access those areas before that time. Please remember that you cannot save a spot and leave your items unattended. The Public Safety Department will **NOT** conduct any vessel inspections, issue a Vessel Operator Permit (VOP) or renew any VOPs on the day of the event.

Other important information to remember:

- 2:00PM the Public Safety Department will enforce the “no wake” rule on the entire lake.

- 7:00PM the Public Safety Department will stop launching vessels at the boat ramp.

- 8:00PM there will be “no activity” on the lake. All vessels must be beached or on the north end of the lake.

- Per the Fire Marshal, after the firework show is over, there will be “no activity” on the lake until the lake siren has sounded the “all clear”.


